Description of Play

You will place a bet, according to how lucky you feel. The croupier will select a "point," or number that you will attempt to reach. By rolling your dice, you add up the total of each roll until you reach your goal. For example, if your goal is 40, you attempt to roll your dice until your dice throws add up to 40.

This seems simple, EXCEPT that you aren't told your actual goal number! Instead, you're given an approximation of your goal, which can be off your actual point by as much as 15%. In the example above, with your goal being 40, you would be told that your Approximate Goal is a number from 40 to 46 -- it's up to you to figure out when you've hit the real point. To help you, the croupier will allow you to be a few points off, as long as you don't go over your true goal. In fact, he's a great guy, and he'll even tell you how close you have to be to the goal point to win.

Now it's not so easy, is it? For your first few plays, bet low until you get the hang of the game. Be careful trying to roll right up to the Approximate Goal, which is almost always higher than your real point -- you'll lose going over, or will get a big roll that puts you out of range. The pay-off for getting within range of your true goal is 1:1. If you're lucky enough to match your goal point exactly, you'll win 2:1 !

How to install this program

1. Read through these instructions before you do anything.
2. Unzip this archive to a temporary directory.
3. Put the sound files in your support files directory, or make a new one for VR software files. The file containing RollAway sounds is available separately as **VRADVNC.D.ZIP**. If you're going to provide the sound files in another way, like VR's Launch Pad software, you may skip items 3 - 5.
4. In *Arthur*, add the new files to the library. Note the *ID NUMBERS* of the library and **VRADVNC.D.ZIP** file, as you'll need these later.
5. Add *download actions* in the hotspots, filling the blanks with the library and file number for the sound files. You should title this something like "D/L RollAway Sounds."
6. Add a *hotspot/button* to your desired screen for the game launch.
7. Place a *Plug-in action* in the hotspot. Use **ROLLAWAY.DLL** on the first line.
8. Add *hotspot/buttons* to your desired screen for the files downloads.
9. Copy **ROLLAWAY.DLL** into your *EXCAL* directory, the **ROLLAWAY.EXT** file to your screens directory.
10. Test each of the screen buttons to ensure proper function.
11. Invite everyone to try it out!
12. At the end of your evaluation period, you should either purchase a full license (see below) or discontinue the use of the software. You may not charge for or modify the software in any way.

-- OPTIONAL TOP 10 SCOREBOARD -----

A. Add a *hotspot/button* to your desired screen for the scoreboard launch.

B. Place a *Plug-in action* in the hotspot. Use **ROLLAWAY.DLL** on the first line. On the second line, put the word **SCOREBOARD**. When selected, RollAway will show the Top 10 list.

If you already have a VRSOFTWARE.INI file, highlight the [Rollaway] section, cut it out and paste it into your existing INI file at the bottom.

2. Put this file in your WINDOWS directory.

3. Put your ROLLAWAY.KEY file in the directory you've indicated for your KEYPATH= .

4. If you are upgrading from earlier RollAway versions:

A. You must edit your VRSOFTWARE.INI file as described above.

B. You must copy your previous key (VREALITY.KEY) to your KEYPATH=.

C. You must rename this file to ROLLAWAY.KEY.

D. If you do not also have Acey-Deucy, you may delete the earlier key file.

Unregistered RollAway automatically limits use to the first few records of your user base.

The sound files used by RollAway and Acey-Deucy (and some other games) are the same. For the convenience of sysops and their patrons, we attempt to provide a number of high-quality sounds that are useful in several different plug-ins.
